# Threatened WILDLIFE

...don't buy!

These are but only few of the most traded wildlife species. Their counts have dwindled faster than our efforts to protect and save them. **DO NOT BUY ANY PET SPECIES CAUGHT FROM THE WILD!** Catching, trading or owning wildlife without proper permit is against the law, and may consequently lead to severe penalties!

Unless otherwise allowed in accordance with the Republic Act 9147 otherwise known as the Wildlife Resources Conservation and Protection Act, it shall be unlawful for any person to willfully and knowingly exploit wildlife resources and their habitats, or undertake the following acts:

ILLEGAL ACTS	CONSERVATION STATUS	PENALTY
A. Killing and destroying wildlife species except in the following instances: when it's done as part of the religious rituals of established tribal groups or indigenous cultural communities; when the wildlife is afflicted with an incurable communicable disease; when it is deemed necessary to put an end to the misery suffered by the wildlife; when this is done to prevent an imminent danger to the life or limb of a human being; and when the wildlife is killed or destroyed after it has been used in authorized research or experiments.
